Set to break ground in early April of this year, the first Welstone site is located at Mission Crossing, a mixed-use infill project developed by LANE4 in the heart of Mission, KS. It will feature 101 apartments in various styles of one and two bedroom units and total 105,000 square feet on 3 levels. The site will include activity and dining facilities, as well as a state-of-the-art fitness facility called Welcamp.

Our focus on wellness will empower residents to live a more vibrant life and maintain their independence," says Welcov President, Tom Boerboom.

The Welstone at Mission Crossing project is expected to be completed in early 2015. Additional locations across the Midwest are planned to follow.

Included in the base rental rate are two meals per day, daily staff visits, community group outings, scheduled transportation, access to a highly structured

exercise program and activity rooms, and overall wellness monitoring in addition to other amenities. The a la carte services include more intense home health services such as medication distribution, daily living assistance, and individual transportation services.
