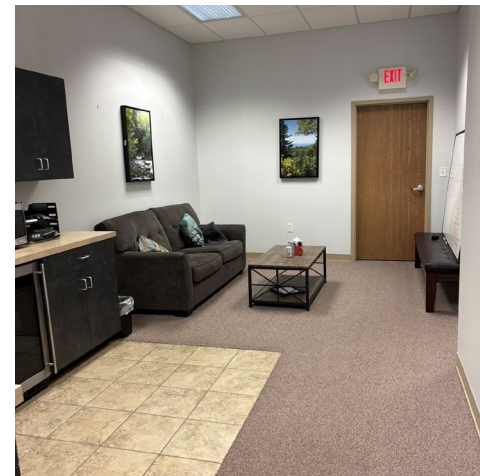
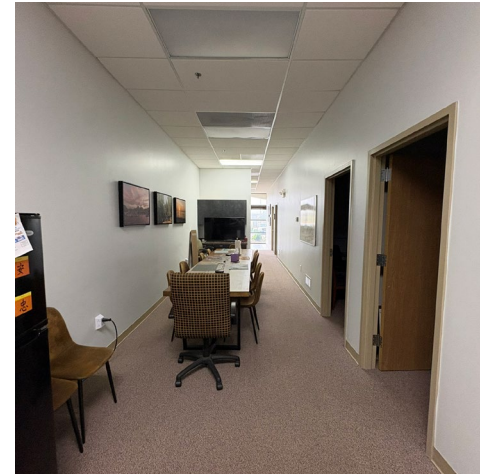
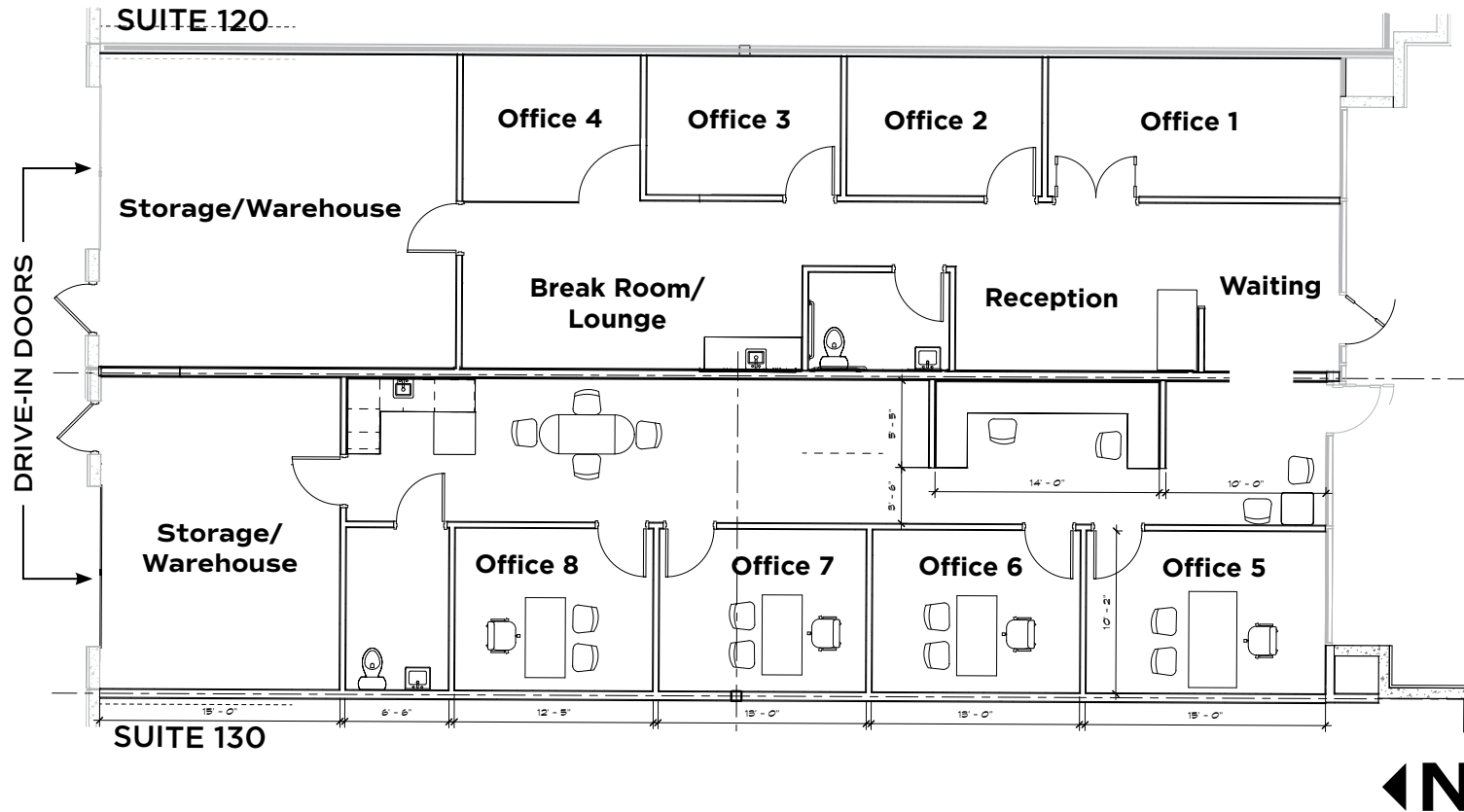
Aerial

UPDATES TO THE BUILDING

JULY 2026

New asphalt in the front parking lot, replaced sections of curbs & handicap mats, and replaced concrete pad at the trash dumpster. The lot was re-striped, along with bringing the fire lane markings up-to-code.

MAY 2026

5 year fire sprinkler system inspection, including repairs.

FALL 2025

Trimmed all trees/bushes around/on premises. Removed and replaced front landscaping outside each unit. Rerouted drip lines to cover new plantings. Installed rock in planter beds.

SPRING 2024

The roof was coated in Silkoxy Silicone and has a 15 year no leak warranty.

SPRING 2023

Painted the upper ribbon across the front of the building to freshen up the exterior.

FALL 2022

Lighting all around the building and in the parking lot light poles were retrofitted to accommodate LED bulbs. Has saved a lot of money over the course of time; the old bulbs were constantly burning out and needing an electrician to come out and replace.



Tenant Overview

NDRI-USA evolved out of the National Development and Research Institutes, Inc., which was established in 1967 to advance and utilize scientific knowledge toward innovative solutions for substance abuse, mental health problems, HIV/AIDS and related medical and social concerns, especially among high-risk populations. NDRI-USA has produced ground-breaking medical, public health, and social sciences research for over 50 years. Our scientists have developed internationally recognized programs of research targeting military and veteran population, first responder, and security services health and readiness, homeland security, sexual, gender, and racial health disparities, and international public health and infectious diseases, in addition to substance abuse research.

Our high impact research is funded by the National Institutes of Health (NIH), the Department of Homeland Security (DHS), Department of Defense (DoD), and a number of different private foundations. In addition, NDRI-USA opened the Social Sciences Innovation Corporation (SSIC), a for-profit company offering consulting services and product development. NDRI-USA/SSIC reflect our exciting evolution and improvements in institutional efficiency while still honoring the long history of successes by NDRI-USA.

Together, the NDRI-USA/SSIC conduct research and provide solutions for pressing health and safety issues nationally and internationally. In addition to our broad research mission, NDRI-USA/SSIC offers the following services to the business and scientific community: 1) Research and Grants Management Services and Business Consultation; 2) Data Science Core Management and Analytics Services; and 3) Product Development and Testing. For example, we currently offer focused training for the US Fire Service (e.g., increasing diversity, reducing bullying and hazing, and surviving the impact of repeated traumatic and physical stresses) and Law Enforcement Agencies (e.g., Naloxone training for first responders on how to respond to and reduce the impact of opioid overdoses).
